## 未成年のカナダ渡航同意書

- ◆ カナダに未成年が単独で入国する時は、入国審査官が人身売買や家出人でないかどうかを厳しく確認する場合があります。入国審査時のトラブルを避けるため、参加者の皆さまには、親権者の同意を得ている旨を証明する目的で、渡航同意書の用意をお願いしています。下記記入例を参考に「Recommended Consent Letter for Children Travelling Abroad」にご記入とご署名のうえカナダまで持参ください。入国審査官に何も聞かれなければ見せる必要はありません。
- 注1:同意書に両親(2名)の署名ができない場合

離婚や死別等のため法的な親権者が1名の場合、署名は1名で結構です。 法的な親権者がお一人と証明するため、戸籍抄本等をご準備されることをお勧めいたします。

注2: 出発時に18才未満の場合

入国時に出生証明書の提示を求められることがございますので、戸籍抄本等をご準備されることをお勧めいたします。
